RESOLUTION NO.22

TO ADOPT A CONTINUING BUDGET AND TAX RATE FOR THE FISCAL YEAR BEGINNING JULY 1, 19<u>88</u>, TO AUTHORIZE THE ISSUANCE OF TAX ANTICIPATION NOTES, AND TO AUTHORIZE THE EXPENDITURE OF FUNDS BY THE VARIOUS COUNTY OFFICES AND DEPARTMENTS

WHEREAS, it now appears that the fiscal year 19<u>88</u> - <u>89</u> budget of <u>sullivan</u> County, Tennessee, will not be approved by July 1, 19<u>88</u>.

NOW, THEREFORE BE IT RESOLVED, by the county legislative body of <u>Sullivan</u> County, Tennessee, meeting in <u>Regular</u> session on this <u>day of</u>, 19<u>89</u>, that:

SECTION 1. The amounts set out in the fiscal $19^{87} - \frac{88}{1000}$ Appropriations Resolution are continued and the various departments, offices and agencies are authorized to expend funds at the same level as the previous fiscal year.

SECTION 2. The property tax rate of $\frac{3.96}{100}$ per each 100 of taxable property for the fiscal year beginning July 1, 19.87, will remain in effect until a new property tax rate is adopted.

SECTION 3. The County Executive is authorized to borrow money on Tax Anticipation Notes not to exceed sixty percent (60%) of the appropriations of each individual fund, provided the notes are first approved by the State Director of Local Finance. The proceeds of such notes to be used to pay the authorized expenses of the county until the taxes and other revenues for fiscal year 19.88 - ...89 have been collected. The notes evidencing the loans authorized under this Resolution shall be issued under the authority of T.C.A. § 9-21-101 et seq. All notes will mature and be paid in full, without renewal, on or before June 30, 1989.

SECTION 4. No local funds can be expended or obligated that exceed the previous year's budget appropriation until a new budget is adopted. Expenditures mandated by the State or rules and regulations adopted by the State are incorporated into this continuing budget.

SECTION 5. This Resolution will take effect from and after its passage and its provisions will be in force from July 1, 19_{BR} until the budget and tax rate for fiscal year $19_{BR} - B_{R}$ is finally adopted and approved. The County Clerk shall include this Resolution in the minutes of the <u>Sullivan</u> County legislative body and send a copy to each county department head.

BE 1T ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF TENNESSEE:

SECTION 1. Section 2 of Chapter 609 of the Private Acts of 1935 as amended by Chapter 27

of the Private Acts of 1935 (first extraordinary session), and Chapter 288 of the Private

Acts of 1974 is further amended by adding the following words after the words "tax

<u>delinguency</u> matters":

unless otherwise assigned to the delinquent tax attorney for prosecution after appointment by the county trustee with approval of the county executive.

SECTION 2 is further amended by adding the following language at the end of the section:

Compensation for the delinquent tax attorney shall be negotiated between the county

trustee in accordance with state statutory procedure and orders of the chancery court regulating delinguent tax collection procedure.

SECTION 2. This act shall have no effect unless it is approved by a two-thirds (2/3) vote

of the county legislative body of Sullivan County. Its approval or nonapproval shall be

proclaimed by the presiding officer of the county legislative body and certified by him to the Secretary of State.

SECTION 3. For the purpose of approving or rejecting the provisions of this act, it shall

be effective upon becoming a law, the public welfare requiring it. For all other purposes,

it shall become effective upon being approved as provided in Section 2.
