

As you are aware, the vacant lot at 913 Hill Street was acquired by Sullivan County at a tax sale in 2006. It is my understanding that Mr. and Mrs. Kevin Carpenter have submitted a bid to purchase this property from Sullivan County. The Carpenters live next door at 917 in a house which they purchased several years ago and to which they have made significant renovations.

The Hill Street neighborhood has been in a state of decline for many years. In an effort to facilitate this area for redevelopment, the city has targeted this neighborhood for code enforcement. In 2004, the city demolished the dilapidated house at 913 Hill Street and placed a lien on the property for the cost of the demolition. In addition, there are liens against the property for delinquent city property taxes.

Mr. and Mrs. Carpenter have been an asset to this neighborhood. The city has agreed to work with the Carpenters to minimize its liens if they are able to purchase the property.
