Mr. Kerney presented a request to rezone a tract of land located in the Thirteenth Civil District on the west side of Moreland Drive north of its intersection with Summerville Road from R-1 to R-3A to permit the location of condominiums.

Mr. Kerney stated that he had developed a subdivision on part of this property, however due to topography the portion of the property he is requesting to be rezoned would be more easily developed as condominiums. He stated that such condominiums would be compatible with development in the subdivision.

Eight residents appeared in opposition to the request and presented a petition asking the planning commission to dany the request. They expressed concerns for property values in the area and stated that most of the homes located in the area were on large tracts and high density development in this area would be incompatible with the existing land uses.

It was noted that terrain in the area was better suited to some form of cluster housing development and recommended that the property be rezoned to PRD (Planned Residential District).

NOW, THEREFORE BE IT RESOLVED by the Board of County Commissioners of Sullivan County, Tennessee, assembled in <u>Regular</u> Session on the <u>21st</u> day of <u>January</u> 1991.

TITIAT WHEREAS, Hicks Lane was layed out, surveyed, constructed, named, maintained, improved and used by the citizens of Sullivan County during pre-Civil War time and into this century; and

WHEREAS, Portions of said Hicks Lane were abandoned, no longer used or maintained and have now been converted to pasture land during this century; and

WHEREAS, That portion still maintained by Sullivan County located in the Arcadia Community was wrongly identified on a subdivision plat (G. W. Ramsey S/D) in 1939 and still bears in some fashion that name (Ramsey Circle; and

WHEREAS, Hicks Lane was named in honor of one of the first families to settle in the Arcadia Community of which the one and only resident facing said Hicks Lane (Bamsey Circle) is a direct decendent of that pioneer family (former Sullivan County Magistrate, Mac Hicks); therefore

BE IT RESOLVED, That upon his request and with respect for history, the original name be properly returned to this remnant of a Historic Community corridor, for now and forever, HICKS LANE.
