F2. Minor Text Amendment to Article 12.104.3, 12.105.2 and 12.108.3 – public notice requirements.

- The county attorney found two minor errors in the Zoning Resolution that conflict with current practice on notifying property owners of upcoming variance requests to the Board of Zoning Appeals.
- The TCA does not require public notices each month for variance requests so long as the meeting date remains the same. Should a special called meeting be proposed, than staff must post public notice in the paper of general circulation. Otherwise, the standard meeting time is made on the monthly county calendar as published by the county mayor's office.
- The county has always gone one step further and required the department to send out letters to all
 adjoining property owners when a variance request has been made. Therefore the zoning code
 should match the current policy and practice of the department.
- Staff found three typos that were improperly cross-referenced in Article XII. Staff recommends the following text amendments:
 - o Article 12-104.3 and 12-105.2 reference to the Notice to Affected Property Owners as specified in Section 12-108.3, Notice by Letter;
 - o Article 12-108.2 Notice by Newspaper delete "or Board of Zoning Appeals" from 3rd line; and
 - o Article 12-108.3 Notice by Letter delete "an appeal" and add "application" from 2nd line.

BE IT FURTHER RESOLVED that money to help-facilitate-this resolution be carmarked from the Health and Safety-Program or Homeland Security Program in an amount no less than five thousand dollars (\$5,000) annually and be dedicated to the rural portions of the County that have utility supplied water service and an insufficient supply line sizing or an insufficient number of fire hydrants.

RESOLUTION Adopting Drug And Alcohol Testing Policy And Procedures For All Medically Licensed And/Or Medically Certified Sullivan County Emergency Medical Service Personnel

WHEREAS, on November 21, 1994, Sullivan County passed Resolution No. 43 adopting an alcohol and drug testing policy for county employees pursuant to the new federal regulations issued by the Federal Highway Administration and the U.S. Department of Transportation; and

WHEREAS, such policy mandates alcohol and drug testing for employees who hold Commercial Driver's License and perform safety-sensitive functions; and

WHEREAS, such policy mandates alcohol and drug testing in the Sullivan County Highway Department and the Sanitation Department; and

WHEREAS, such policy is currently in effect and has been in effect for many years and has been working well; and

WHEREAS, Resolution No. 43 approved November 21, 1994 specifically excluded emergency personnel; and

WHEREAS, medically licensed and/or medically certified employees of Sullivan County Emergency Medical Service work around and/or have access to prescription medication, narcotics, and other medicines that are highly regulated, have a history of abuse, and have high street value; and

WHEREAS, medically licensed and/or medically certified employees of Sullivan County Emergency Medical Service are called upon on a regular basis to provide medical diagnosis, care and treatment upon short notice with due haste, in a professional manner, and according to a high standard of care; and

WHEREAS, medically licensed and/or medically certified employees of Sullivan County Emergency Medical Service are called upon on a regular basis to make decisions and perform services in a hurried environment including, but not limited to, using and interpreting advanced medical technology on patients, administering potent drugs including narcotics, making split second decisions regarding patient care, and protecting patient's safety along with co-workers, all of which affect the health and lives of the public; and

WHEREAS, medically licensed and/or medically certified employees of Sullivan County Emergency Medical Service are called upon on a regular basis to drive emergency vehicles in a hurried manner thereby requiring the employees' utmost attention, abilities and coordination; and

WHEREAS, the safety of employees and the public is sensitive to any impairment that may occur as a result of the use by said employees of drugs and alcohol; and

WHEREAS, it is the desire to adopt for medically licensed and/or medically certified Sullivan County Emergency Medical Service personnel the same alcohol and drug testing policy and the same system of administration that has been working well for many years;

NOW THEREFORE BE IT RESOLVED by the Board of County Commissioners of Sullivan County, Tennessee, assembled in Regular Session on the 17th day of May, 2010, that Sullivan County hereby extends and applies the policy for drug and alcohol testing adopted by Sullivan County on November 21, 1994 by Resolution No. 43 to all medically licensed and/or medically certified employees of Sullivan County Emergency Medical Service (EMS); and

BE IT FURTHER RESOLVED, that the current policy as adopted on November 21, 1994 shall be hereafter read and interpreted, and words changed and substituted as necessary, such as to apply to all medically licensed and/or medically certified employees of Sullivan County EMS;

BE IT FURTHER RESOLVED, that the application of the alcohol and drug testing policy to all medically licensed and/or medically certified employees of Sullivan County EMS is to be implemented and placed into effect on August 1, 2010, and

BE IT FURTHER RESOLVED, that notices of the adoption of this alcohol and drug testing policy shall be posted in the main Old Blountville Courthouse and the office buildings of the Sullivan County EMS prior to implementation of actual drug testing on August 1, 2010; and

BE IT FURTHER RESOLVED, that the Director of Sullivan County EMS shall work with the administration of the current Sullivan County alcohol and drug testing policy in order to be ready to apply the policy to all employees of Sullivan County EMS on August 1, 2010;

BE IT FURTHER RESOLVED that the records for EMS alcohol and drug testing as well as EMS random drug testing procedures and data under this policy shall be maintained independently and separately such that the federal regulations can be complied with regard to CDL drivers under the pre-existing drug and alcohol testing policy.

BE IT FURTHER RESOLVED, that any costs over and above the costs of the existing alcohol and drug testing policy be appropriated in the 2010-2011 Sullivan County Budget.
