This application must be signed under oath in the presence of a notary public and submitted to the County Clerk with the applicable fees. If elected, you will be required to post a bond in the amount of Ten Thousand Dollars (\$10,000). You may post a bond either by purchasing a four (4) year notary bond from an insurance company OR by having two (2) personal sureties sign for you. These sureties must own property in Sullivan County valued in excess of Ten Thousand Dollars (\$10,000). The bond must be filed in the office of the County Clerk, who will accept the required fees and administer the oath of office.

You are <u>not</u> authorized to act as a notary public until you have filed your bond, taken the oath and received your commission from the Governor's office. The certificate you receive from the Governor's office will have your commission dates on it. If you move your residence or your principle place of business out of this county, you are required by law to notify the County Clerk of the change of address.
