Dear Mayor Godsey,

According to the U.S. Census data, there are over 27,500 adults over the age of 18 in our immediate area without a high school diploma, and 2,400-2,500 of these individuals are between the ages of 18-24 years old. This figure represents approximately 18% of Bristol, Kingsport and Sullivan County's total population.

In previous years, the Tennessee Department of Labor and Workforce Development provided financial assistance to students who took the GED test; however, this service is no longer available to our students as a result of significant budget reductions. *Currently, the official GED test costs each student \$65.00*.

Frequently, students enter our program because they are unable to obtain a job because they lack a high school diploma. The following are unemployment rates for our communities: Bristol – 11.6%; Kingsport – 12.0% and Sullivan County 9.4%. The Kingsport/Sullivan County GED program provides a second chance for individuals who did not graduate from high school; however, we cannot do it alone. Last year, our program enabled over 230 individuals to obtain a GED diploma, and subsequently many of those students were able to become gainfully employed or continued their education in college or a technical school.

The testing fee of \$65.00 dollars is overwhelming for many of our students, and we are trying to eliminate one of the barriers that may prevent them from getting their GED diploma. The purpose of this letter is to respectfully ask your consideration to pay the testing fee for Sullivan County residents. During the 2008-2009 academic year, we had 46 Sullivan County residents to obtain a GED diploma, and since July 1, 2009, 21 individuals from Sullivan County have all ready obtained a GED diploma.

For your information, the City of Kingsport has agreed to provide this service for city residents, and I plan to ask the City of Bristol for the same consideration to help breakdown barriers for our students, and to provide them a second chance to obtain their education.







### To Honor And Recognize Heroes Of Fort Hood Attack

WHEREAS, on Thursday, November 5, 2009 the Fort Hood Army Base in Texas came under attack from a Muslim extremist who had infiltrated the military. In the onslaught of this violence. 13 adults were killed, the life of 1 unborn child was taken, and over 30 other individuals were injured; and

WHEREAS, a surprise attack of this kind in an enclosed area demanded quick thinking and immediate defense tactics. Sergeant Kimberly Munley, a civilian Department Of Defense Police Officer, along with her partner, Senior Sergeant Mark Todd arrived on the scene within a very few minutes of getting the call. Sergeant Munley despite being shot herself, continued to fire at the shooter. She and Sergeant Todd disabled the assailant from continuing his attack; and

WHEREAS, we in America realize that we owe our freedom of speech, freedom to worship as we please, freedom to seek education and employment opportunities, freedom to bear arms, vote, and live peaceably to the repeated dedication and sacrifices that our military veterans have exhibited both on American soil and in foreign lands; and

WHEREAS, the commitment and expertise of American military personnel has preserved the lives and freedoms of many foreign countries when the call has come out for help – and those nations exist on their own today due to post war aid freely given by the USA; and

WHEREAS, we in Sullivan County wish to salute the military, civilian forces, and Fort Hood community for their quick action to bring down the assailant while rescuing others under attack and commend their unity in coming together to comfort those whose family members were slain in this vicious attack and to lend support to the many wounded.

NOW THEREFORE BE IT RESOLVED, that the Sullivan County Board Of Commissioners and Sullivan County Mayor Steve Godsey, on behalf of the citizens of Sullivan County, hereby extends our gratitude and support to the Fort Hood Community for their bravery in the face of horrendous danger, and extend our sympathies and prayers to all of those suffering in the aftermath of this tragedy. We are proud to call all of you honorable American patriots.

### RESOLUTION To Improve Fire Safety Within The Borders Of Sullivan County

WHEREAS, Sullivan County has the obligation to our citizens to improve fire safety; and

WHEREAS, Sullivan County has no standards on the size of water service lines or the placement of fire hydrants serviced by any public utility provider; and

WHEREAS, there are areas within the borders of Sullivan County with insufficient supply line sizing and lack of sufficient fire hydrants for adequate fire safety.

NOW THEREFORE BE IT RESOLVED that the Board of County Commissioners of Sullivan County, Tennessee, assembled in Regular Session hereby require all water utilities within the County, including all municipalities, to install fire hydrants and supply lines in all new, replacement, and upgrade construction to the standards required within residential areas inside the city limits of Kingsport or Bristol, Tennessee; and these be checked and maintained on a regular basis on a schedule no less than what's provided within the boundaries of the cities.

BE IT FURTHER RESOLVED that if any utility provides service to an industrial park or other major industrial site, sufficient water supply, line sizing and fire hydrants must be installed to meet or exceed any codes required within the city limits of Kingsport, Bristol, Tennessee, or any other utility district providing service in Sullivan County.

BE IT FURTHER RESOLVED that money to help facilitate this resolution be carmarked from the Health and Safety Program or Homeland Security Program in an amount no less than five thousand dollars (\$5,000) annually and be dedicated to the rural portions of the County that have utility supplied water service and an insufficient supply line sizing or an insufficient number of fire hydrants.

BE IT FURTHER RESOLVED that \$5,000 annually be put in each year's budget to help facilitate this resolution. This money is to be put in the Health & Safety program overall Planning & Zoning Department's Budget. The \$5,000 annually to be dedicated to the rural portions of the County that have utility supplied water service and no fire hydrants or an insufficient number of fire hydrants.

RESOLUTION Requesting New Bridge Currently Under Construction On State Route 75 (Located Downstream From Boone Dam) Be Named As A Memorial to Riley Lee Milhorn And Orville Depew "Dick" Kitzmiller

WHEREAS, Riley Lee Milhorn was the son of Robert Lee and Lura Alice Milhorn. He was born May 9, 1909, and was raised on a farm located on the present site of Boone Dam. He resided in a home located adjacent to the existing bridge until his death; and

WHEREAS, Mr. Milhorn's ancestors first arrived in Sullivan County in November 1789. They received a land grant from North Carolina for 200 acres in the Fork Section on the south side of the Holston River. His parents purchased a farm on the right side of the South Holston River extending downstream to the tip of Spurgeon Island located adjacent to the new bridge under construction. The farm house stood on the current site of the generating plant at Boone Dam. Riley and his family continued to farm the land until the farm was purchased by the Tennessee Valley Authority in November 1950. Riley and his two brothers purchased land on both sides of the current Highway 75 Bridge. They farmed the land to provide a living for their children and grandchildren until their deaths. The family continues to own land on both sides of the existing Highway 75 Bridge; and

WHEREAS, in the 19308 Riley jointed the Works Project Administration (W.P.A.). He helped construct a road through the Great Smokey Mountains National Park. By being part of the W.P.A, he was able to send money home to help his parents and siblings during the Great Depression; and

WHEREAS, during World War II, Riley was a foreman at the Holston Ammunition Plant. He and his crew helped build ammunitions used by our troops. After the world he transferred to Tennessee Eastman where he worked until retirement; and

WHEREAS, Riley Milhorn's ancestors moved to the banks of the Holston River and the Milhorn family continues to live near it. The Milhorn family has always been hardworking citizens of Sullivan County. The Holston River and the land around it has always been special to the Milhorn Family; and

WHEREAS, the Milhorn family has requested that Sullivan County consider naming the new bridge over the South Fork of the Holston River near Boone Dam in honor of Riley Lee Milhorn; and WHEREAS, Orville Depew "Dick" Kitzmiller was the son of Zed and Chessie Kitzmiller. He was born May 14, 1919 in Sullivan County and lived his life just a couple of miles from the bridge being built near Boone Dam. Prior to enlisting, he farmed the land near where the new bridge is being built; and

WHEREAS, Private Kitzmiller joined the Marines on June 25, 1943 and received his basic training at San Diego, California. He went overseas in January of 1944. A member of the First Battalion, Third Marine Division, he was stationed at Guadalcanal several months before going into action in the Marianna Islands. He participated in engagements on New Caledonia and Guadalcanal just prior to his death on the island of Guam; and

WHEREAS, a fellow Marine and eyewitness to the events told family members that on the morning of July 23, 1944. Pfc. Kitzmiller and a few other Marines were assigned the duty of taking out enemy snipers on the beach of Guam before the main body of Marines disembarked from the landing craft. They threw smoke flairs over the area where the enemy was entrenched. U.S. planes were to fly over and drop bombs on the enemy guided by the smoke. But the wind shifted just as the planes arrived and Pfc. Kitzmiller was killed by friendly fire. He was awarded the Purple Heart posthumously; and

WHEREAS, his body was returned in 1948 and was buried in Beulah Community Cemetery on October 27, 1948. He was a member of Beulah Baptist Church, and much beloved in the community; and

WHEREAS, to honor the ultimate sacrifice that Marine Private Orville D. Kitzmiller paid for his family, his community, and his nation, the family of marine Private Orville D. Kitzmiller has requested that Sullivan County consider naming the new bridge over the South Fork of the Holston River near Boone Dam for him.

NOW THEREFORE BE IT RESOLVED that the Board of County Commissioners of Sullivan County, Tennessee, assembled in Regular Session on the 16<sup>th</sup> day of November, 2009 hereby authorize that the new bridge currently under construction on State Route 75 located in the 7<sup>th</sup> Commission District be named in memory of Riley Lee Milhorn and Orville Depew "Dick" Kitzmiller, with signs being placed in their memory at no cost to Sullivan County.

WHEREAS, on February 26, 2002 the Sullivan County Historical Preservation Association (SCHPA) entered into "Preservation Agreement" with the State of Tennessee imposing obligations upon the SCHPA for a period of 15 years (through 2/26/2017); and

WHEREAS, the Sullivan County Commission on May 20, 2002 passed Resolution No. 5 (2002-04-41): 1) approving the transfer of "the Old Deery Inn, Rutledge House and surrounding property" to Sullivan County subject to the Preservation Agreement; 2) delegating to Sullivan County Historical Preservation Association the "authority to manage the day-to-day operations of the Old Deery Inn, Rutledge House and surrounding property and to implement and coordinate the activities associated with the renovation and restoration of downtown historical Blountville"; and 3) establishing the Historical Advisory Board (now known as Preservation and Tourism Advisory Board pursuant to Res. No. 2009-02-14 approved March 16, 2009) and setting forth its make-up and objectives; and

WHEREAS, the Sullivan County Commission on June 17, 2002 passed Resolution No. 23 (2002-06-87) approving the "Partnership Agreement" between Sullivan County and the Sullivan County Historical Preservation Association setting forth terms of understanding regarding management of Deery Inn, Rutledge House and surrounding property by Sullivan County Historical Preservation Association; and

WHEREAS, the Sullivan County Commission on September 16, 2002 passed Resolution No. 4 (2002-08-112) approving the "Partnership Agreement" as amended; and

WHEREAS, the Sullivan County Department of Archives and Tourism is the proper branch of Sullivan County government to handle and be responsible for the day-to-day management of the Rutledge House, the Old Sheriff Home, the Anderson Townhouse, and the Community Center; and

WHEREAS, pursuant to Section Eight (8) of the "Partnership Agreement", permanent inventory records of personal property located inside and outside at the Old Deery Inn, the Rutledge House, the Old Sheriff Home, and the Anderson Townhouse were to be prepared and updated by the Sullivan County Historical Preservation Association, Inc. and will now need to be updated to reflect what personal property hereafter remains with the Old Deery Inn subject to the "Partnership Agreement" and what personal property goes with the Rutledge House, the Old Sheriff Home, the Anderson Townhouse, and the Community Center when management is transferred to the Sullivan County Department of Archives and Tourism.
