

A RESOLUTION REQUESTING THE AMENDMENT OF TENNESSES CODE ANNOTATED § 57-5-105(g) SO AS TO INCREASE THE APPLICATION FOR A BEER PERMIT FROM \$100.00 TO \$200.00.

WHEREAS, Tennessee Code Annotated § 57-5-105(g) provides that the applicant for a beer permit shall pay the sum of \$100.00 as an application fee for use in offsetting the expenses of investigating the applicant and the publication of notices required by the Beer Laws of the State of Tennessee; and

WHEREAS, the sum of \$100.00 is not sufficient to offset the increased cost of administering the beer licensing system in Franklin County, as well as other counties in the State of Tennessee; and

WHEREAS, it will be necessary that the general law be amended, and this Franklin County Commission is of the opinion that said application fee should be increased from \$100.00 to \$200.00;

NOW, THEREFORE, Be It Resolved by this, the County Commission for Franklin County, Tennessee, as follows:

- 1. The County Commission for Franklin County, Tennessee, does hereby recommend that <u>Tennessee Code Annotated</u> § 57-5-105(g) be amended so as to increase the application fee for a beer permit from \$100.00 to \$200.00.
- 2. The County Commission for Franklin County, Tennessee, does hereby urge and request State Senator Jerry Cooper and State Representative Billy J. Rigsby to introduce legislation in the Tennessee General Assembly providing for said amendment and to work for the passage of said legislation.
