To the Honorable Steve M. Godsey, Mayor of Sullivan County, and the Board of Sullivan County Commissioners meeting in Regular Session this 17th day of October, 2011.

RESOLUTION To Approve Entering Into A Contract With Humana United Health Insurance To Provide Employee Health Insurance Coverage For Sullivan County Employees Effective January 1, 2012

WHEREAS, the Insurance Committee has reviewed various employee health insurance renewal proposals for the 2012 year; and

WHEREAS, the Committee has recommended a contract with Humana United Health to provide the Silver and an optional High-Deductible Savings Plan with a 4-tier billing rate for each plan and an additional employee option to buy-up on the Silver Plan for a lower deductible.

NOW THEREFORE BE IT RESOLVED that the Board of County Commissioners of Sullivan County, Tennessee, assembled in Regular Session, authorize the Purchasing Agent to enter into a contract for Employee Health Insurance with Humana United Health Insurance for the 2012 calendar year, the employee's share of cost for each plan shall be based on 12.5% of the monthly premium for the Silver plan.

BE IT FURTHER RESOLVED that half of the increase in increased cost for the insurance premiums be allocated to the employee County share for each of the basic plans <u>through June</u> <u>30, 2012</u>.

BE-IT-FURTHER-RESOLVED that the remainder of the funding increase be provided with an additional \$50 surcharge for each spouse on the plan and each employee that has not participated in the elective health screening provided by the County.

BE IT FURTHER RESOLVED that the County's contribution for each of the basic plans (Silver and HDHP) shall be used as a contribution amount for the employer's share of the contribution for the optional buy -up on the lower deductible Silver plan.

<u>BE IT FURTHER RESOLVED that a wellness program be developed and implemented by July 1, 2012 under the supervision of the Health Insurance Committee.</u>

This resolution shall take effect from and after its passage. All resolutions in conflict herewith be and the same rescinded insofar as such conflict exists.
