RESOLUTION For Approval Of An Economic Impact Plan Of The Industrial Development Board Of The City Of Bristol, Tennessee, For Bristol West For The Pinnacle Development

WHEREAS, the Industrial Development Board of the City of Bristol, Tennessee ("IDB") pursuant to the provisions of Tennessee Code Annotated, § 7-53-312 and related provisions, as supplemented and amended, has the power and authority to implement economic impact plans located within its statutory boundaries; and

WHEREAS, the IDB has prepared a document entitled "Economic Impact Plan for the Bristol West Economic Development Area (the "Plan") in conformance with Tennessee Code Annotated, § 7-53-312, as supplemented and amended, which has been adopted by the IDB pursuant to a Resolution adopted September 7, 2012; and

WHEREAS, the Plan authorizes financial assistance to the developer of the project through the use of tax increment financing as described in the Plan; and

WHEREAS, the IDB conducted a public hearing on September 7, 2012, relating to the Plan; and

WHEREAS, the comments and findings of said public hearing, along with the Plan have been presented to the Sullivan County Commission; and

WHEREAS, the IDB has recommended the adoption of the Plan by the City of Bristol, Tennessee, and Sullivan County, Tennessee.

NOW THEREFORE BE IT RESOLVED that the Board of County Commissioners of Sullivan County, Tennessee, assembled in a Called Session on the 7th day of September, 2012 adopt the following:

- 1. That the Economic Impact Plan for the Pinnacle Development Project as presented and recommended by the IDB, a copy of the Plan being attached hereto as Exhibit A, is hereby approved and adopted by the Sullivan County Commission.
- 2. That use of tax increment financing as described in the Plan for the Pinnacle Project.
- 3. That the Sullivan County Mayor and Sullivan County Assessor are hereby authorized and empowered to execute all such documents as may be reasonably required to implement this Plan.
- 4. That the IDB is hereby authorized and empowered to implement the Plan-on-behalf of Sullivan County.

This resolution shall take effect from and after its passage. All resolutions in conflict herewith be and the same rescinded insofar as such conflict exists.
